American Rescue Plan (ARP) Act Elementary and Secondary School Emergency Relief (ESSER) Funding

New York State has been allocated nearly \$9 billion in-PASSER funds. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the defithes ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). eligible LEAs ARP-ESSER 90% base allocation may be fourthere.

Application Process and Timeframes

Under section 2001(d)(2) of the American Rescue Plan (ARP) Act of 2021, each State Educational Agency (SEA) must make ARPESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives SERPRIPINGS. The first portion of ARESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Departnown Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs.

To enable New York State s LEAs to begin to obligate-**ARS**ER funds by USDE s May 24, 2021 deadline, the application for LEA 90% base ARESSER allocations will be administered by NYSED as a twopart application process:

x ARP-ESSER Application Part 1: The first step, as outlined in this memorandum, is for each LEA to submit signed assurances to SND by no later that May 24, 2021 Upon receipt of signed LEA assurances, NYSED will provide an emaitice to the LEA of

- substantially approvable application status. Upon receipt of such notice, LEAs may begin obligating their allocation of 90% base ÆSSER funds.
- x ARP-ESSER Application Part 2 The second step will be the submission of a full application and budget by the LEALYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. 272 of the application will be issued the coming weeks NYSED will inform LEAs under separate cover when the application process for LEA 90% base-1268 allocations has been published in the SED Monitoring and Vendor Reporting System

Application Process Step One, Submission of LEA Assurances

LEAs are asked to submit signed ARESSER assurances to NYSED by no later thanday 24, 2021. The assurances may be accessed in the SED Monitoring and Vendor Reporting Strategy temporal completing the following steps:

- 2. Click on the Log In button
- 3. Enteryour username and password
- 4. Click on SED Monitoring and Vendor Performance System under My Applications
- 5. Select View Surveys for the Office of ESSAnded Programs
- 6. Find the survey title ARP-ESSER Application Part 1
- 7. Click on view to begin/continue to input information

Application Process for LEA Allocations of ARP -ESSER SEA Reserve Funds

The federal ARP statute requires State Educational Agencies (SEAs) to reserve:

- x not less than 5 percent of the total amount of grant funds awarded to the State (\$449.4 million) to carry out activities to addites impact of lost instructional time by supporting the implementation of evidenbased interventions;
- x not less than 1 percent (\$89.9 millions) artray out the implementation of evidebressed summer enrichment programmend
- x not less than 1 percent to carry out the implementation of elaborate emprehensive afterschool programs.
